On January 19Brewersubmitted a formal complaint to IE.

POTENTIA POLICY IOLATIONS

I delivered a Notice of Allegation (NSOA) to Jacob Tower

based on the totality of the circumstances. Incapacitation is more than intoxication but intoxication can cause incapacitation.

Factors to consider in determining incapacity include, but are not limited to, the following:

- a. Lack of awareness of circumstances or surroundings (e.g., an inability to understand, either temporarily or permanently, the who, what, where, how and/or why of the circumstances; blackout state)
- b. Inability to physically or verbally communicate coherently, particularly with regard to consent (e.g., slurred or incoherent speech)
- c. Lack of fulbontrol over physical movements (e.g., difficulty walking or standing without stumbling or assistance)
- d. Physical symptoms (e.g., vomiting or incontinence).

APPLICABLE

MICHELLBREWERMU STUDENT

I first met with Michelle Brewer orMonday, January15, 2024, over Zoom. During our meeting, she described an incident implicating one of the University's Nondiscrimination Policies. On January 19 Brewersubmitted a Firmal Complaint along with a detailed statement alleging that on January 01224, student Jacob Toweengaged in Sexual Assaultondling and/or Rapevith her at Kappa Zou's fraternity house located 155 Main Street. She reported that she was unable to recall all the events of the night due to her level of incapacitation. Below is a summary of the information collected during the course of the investigation.

Brewerreported that she and Towernet during the Springemester of their freshman year and became friends. She stated,

We first met inMarch (2023). We had some classes together, but we never really talked much. But then I joined the Chemistry Clubid semester and that's where I started talking to him. We then started hanging out more.

When asked how often they hung out together, slaeds "Besides Chemistry Club meetings, we would hang out maybe once a week or once every two weeks. A smaller group of us liked to do different things together, like karaoke or just hang out at Jacoba his roommate's place. It was just kindworfatever."

Brewerthen began to describe what occurred the night of the incident. She recalled \$\dagger\$1.8 (0)7e-3.6 (ua.4 (.)14.9 (

It didn't seem like more than normal. I can usually drink a lot, but it was different this time. I didn't have as much to eat as normal. I don't know if that was different or maybe it was that I drank a lot pretty quickly because I kept losamed I had those tequila shots before leaving Breanna's have never blacked out or forgotten a night though. That's what is so weird about this.

I askedwhat she had to eat that dapindshe said, "I had a bagel for breakfast and a salad for a late lunch. I didn't really eat much for dinner; I just had some chips with cheese dip and salsa at Breathers wasn't food at the party."

Brewerwas then asked to describe whate felt when she began feeling sick. She stated,

I first noticed that the room seemed weird, like it was moving, but I knew I wasn't [moving]. I felt off kind [of] dizzyThen I started to feel nauseous. That's when I went to sit down in the living room. It's right off the dining area, which is where the **beeg** table was

She was then asked to describe what happened while she was sitting down in the living room. She recalled,

That's where I really get confused. I remember sitting and Snapchatting, and at another point, I remember standing and talking to people. I don't really remember what we were talking about, but I remember we were laughing. The next thing I remember ig bein Jacob'soom, but I have no idea how I got there. It's like I was just there, on his bed, and he was on top of me.

Brewerstated that she recalls talking thowerat the party and remembers that he was part of the group she was talking with in the living room. When asked who else was in the group she was talking with, she stated, "I remember it was acoband Breannawho were all talking and laughing." I asked ther she told anyone that she felt sick and she replied, "I don't remember if I did. I think people could probably tell though."

When asked why she thought others would be able to tell, she said

I just felt so weirdand since I can't remember parts of the night, I'm sure it was obvious to others. I felt unsteady. I was able to walk around somewhat okay; like, I didn't need help to stand up. I just felt odd.

When asked how many people were at the party, Brestated,

Not a lot, maybe a total of six or seyemut not everyone was there the whole time. I also didn't know them all. It was a mixed group. That's one reason I brought Brehreadly only knewJacoband his roommate, Jaspeton.

I then asked follow-

Thanksgiving reak (late Novembe 2023). We were on the same trip together. We both had been drinking a lot and hooked up. That's the last time we hadn't hung out again until the party at Kappa Zou anuary 122024).

I askedwhether they had communicated with each other since the Thanksgir Binegak trip She stated, "Yes. We mostly send Snaps to each other."

Brewerwas asked to describe how their prior sexual interactions differed from the night of the reported incident. She stated.

I remember the details of every other time we've had sænxd I can't remember the details of this night. I must have been too drunk. I passed out and only remember little parts of what happened. I remember wanting to say something but not being able to. And then I just remember waking up the next morning. Itfaels so shocking, and when he was acting like everything was normal to him, I just don't feel like it was. I don't understand how it could be. I mean, I didn't even remember spilling my drinken apparently that happened.

When asked what drink she spilled, she explained that Towlether the next morning via text that she had spilled beer on her shirt while they were talking in the living room. She added, "I apparently spilled it on my shirt, and they were laughing. I remember the land obtained Breanna laughing at something, but I didn't know that was why." JACOBTOWER MU STUDENT

I met with Jacob Toweand his support person on February 27024, over Zoom. Below is a summary of the information collected during the course of the investigation.

Towerstated that he was at the party the night of January1822024. He stated it was at his fraternity house (Kappa Zou)and he was there for the entire partywhich started around 7:00 p.m. and ended around midnight. He said that he lives with one other roommate, Jasper Abweloo was also at the party that night.

When asked how he knows the Complain antichelle Brewer, Towerreplied,

We met in Chemistry Club last yella(rch2023). I would say that we're friends and we hang out pretty regularly. We are...I guess you would say...sort [of] like, friends with benefits. We've hooked up on a few different occasions, like just random times and then over Thanksgivin (late November 2023). That was the last time we had sex before this nighthte

We had sex then and it felt the same as this time. This is the first time she hasn't remembered though. That's still so weird because it seemed like she was into it.

I askedwho usually initiates sex, an bwerreplied, "Both of us do. Maybe me more than her, but we both have."

I asked how frequently he and Brewæmmunicate with each othen owerreplied, "Pretty regularly. We talk at Chemistry Club and then mostly talk through Snapchat." When asked if they have had regular communication since the hanksgiving Break trip, he stated, "Yeah, it's been pretty regular." I asked whether they talked about having sex again (after Thanksg Briegk), and he answered "No, not really. Wariltsbaretis. In Neor 6160 (WAS 91 () and Tun (g)2.m)-6.3 (e)7.8 (wc -0.02 1 (w)d)] TJ 0 Tun ged

When asked how much alcohol Brewæmsumed at her apartment, ewisreplied, "I'm pretty surewe each had like three shots before the bety got there. Two shots of tequila and one of vodkæwisstated they drank the shots of alcohol within about 2025 minutes and left shortly before 10:00 p.m. I asked Lewisif she noticed whether Brewæppeared intoxicated at this point of she responded, "No, she was fine when we left. She ordered the Uber and was chatty like normal. She was fine."

Lewiscontinued by describing what occurred once they arrived at the party. She stated,

I don't really know what to say. Nothing really stuck out about the party. It was just very typical. I did seeMichellespill her drink when she was getting up to go to the bathroom It's like she got up and was talking and holding her drink. Then, it tipped and spilled on her shirt. That's about it though. Thing 3 (e) 7.82 (s) 6.5 (ge) -6



next to Tower, Abreostated, "She was just kind of standing right by him in the kitchen, which is in between the dining area and living room. I think she had her hand on his arm or something. That's really all I remember." When asked if he saw Toværd Brewerkiss, he stated, "No."

Abreo said that he never saw Brewterave. He stated that he and his girlfriend went to his bedroom around 11:00 p.m.

When asked when he heard about what is being alleged to have occurred, he stated, "I heard about it when Jacobgot that letter. He was shocked." In response to whether Totalered to him about what occurred before getting the Notice from our Office, he said, "Not really. He did mention the text conversation between him and Michelbecause he thought it was kind [of] strange at the time. But, he didn't say anything more until he got that letter." I asked if Towerally talks about things like that with him, and Abreoreplied, "No, not usually. I mean, he told me about the timeToranksgivingBreak, but he doesn't usually talk about his sex life." In response to wheTowererhas shared more details with him now, Abreostated,

He's worried about what may happen and feels bad that she thinks these things about
